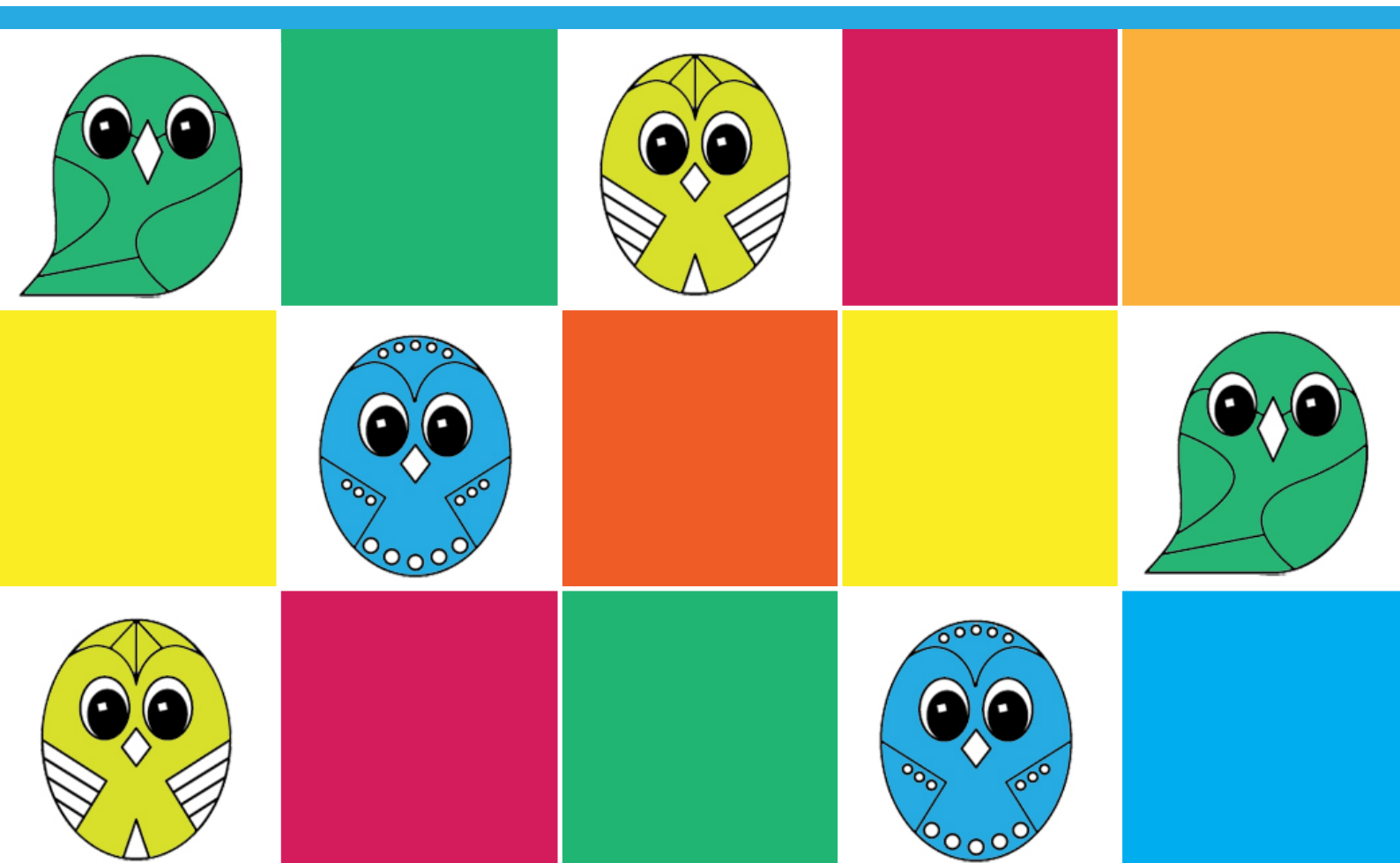


Athena MIS Licence Options & Additional Services



About Athena MIS

Athena MIS is ILR compliant, cloud based, data management software with integrated ePortfolio, used to track, monitor and comply with ESFA funded and non funded commercial provision. Athena MIS provides your company with its own secure database with unlimited access and offers you the ability to create unlimited users without additional licence fees!

For a limited time Phase 1 of our integrated ePortfolio is included in the licence fee!

The Athena MIS Dashboard tabs display your candidate data visually through graphs and charts allowing you to track reviews, complete missing data, track progression of main aim and functional skills along with learner contact and Individualised Learner Record (ILR) data.

Dashboards:

- **Home** - monitoring mandatory data, IQA's & reviews due.
- **Functional Skills** - monitor learner progression from initial assessment to completion.
- **Destination** - monitor learner destination on completion of apprenticeship.
- **Progression** - monitor and report on candidate progression and contact throughout their learning journey.
- **Notifications** - track notifications through the annual planner.
- **Finance** - track payments outstanding and received.
- **ILR** - track and monitor learner ILR data requirements and generate ILR's in XML format for validation and submission to the Education and Skills Funding Agency.
- **Ofsted Reports** - data required by Ofsted is automatically generated from candidate data input.

Key Features:

- **ILR** data monitoring for the production successful ILR returns.
- **Integrated ePortfolio** - upload evidence directly into the learner profile!
- **Contract Tracker** - monitor contractual obligations to avoid under delivery.
- **Cohort Manager** - including automatic creation of review schedules. Automatic email to assessors with upcoming reviews.
- View candidates due to complete by month filtered by main aim, functional skills, knowledge and competency elements.
- Monitor & report on participant feedback.
- Monitor IQA and Certification.
- Course Management tools.
- Instant reporting.
- **Ofsted Report** data in real time.
- Automated email functionality for assessors / tutors for when reviews are due.
- Bespoke report generation.
- Export reports to MS Excel for use in your own annual reports.

The Course Management tools utilises the Lars database to search for courses to build Apprenticeship frameworks and standards. You can also create packages of short courses and 'My Custom Units' provides the facility to create none accredited units and courses which you may offer as an addition to the accredited provision or for internal staff training purposes.

Athena MIS can also be used to track and monitor your internal staff training by using the Work Place Learning learner type. Athena MIS is extremely flexible allowing you to build bespoke training courses and track completion by site location and department.

Athena MIS Licence Fees

Several licence options:

1. Athena MIS App10* - up to 10 apprentices	£2,400 per annum (£200.00 pm)
2. Athena MIS 250 - up to 250 learners	£3,600 per annum (£300.00 pm)
3. Athena MIS 500 - up to 500 learners	£5,400 per annum (£450.00 pm)
4. Athena MIS Unlimited - unlimited learners	£9,000 per annum (£750.00 pm)

*This is an initial licence fee for training providers new to apprenticeship delivery. If you only ever have 10 apprentices a year then your licence fee will stay at this level, once you have more than 10 apprentices the licence fee will increase.

A setup process fee of **£350.00** is required for App10 or Athena MIS standard licence and **£450.00** for Athena MIS Unlimited.

Your Athena MIS will be available and accessible within a few hours of receiving:

- Set up fee
- Set up of standing order
- Signed SaaS licence agreement

Depending on your requirements the setup process could take several days and includes; course, cohort, contract and use account creation, basically it's everything you need to get up and running as quickly as possible!

Additional Services:

• On site training	£450.00* per day
• Data management including support with ILR submissions	£150.00 per day
• Full data management & monthly ILR submissions	from £450.00 per month
• **Bespoke ILR support & guidance	from £150.00 per month

*In some cases travel and expenses maybe an additional cost.

- **Trainer Credentials** - Further extension of the Assessor roll to include a professional profile to include current qualifications, vital renewal and expiry dates and CPD requirements.
- **Candidate Types** - As new candidate and contract types become available we will develop these areas into Athena MIS, enabling you to expand your training provision.
- **Ofsted Requirements** - We build in as many of the latest requirements as are appropriate such as functional skills progression, destination & progression and achievement statistics.
- **ESFA Compliance** - Most of all Athena MIS will develop based on the funding rules and specifications set by the Education and Skills Funding Agency.
